23	SECURITY CAMERA PRESENTATION
24 25	The purpose of this workshop is to introduce the concept of next generation license plate reading cameras and explore their possible integration into the Sheriff's 911

- 1 dispatch and operations facility. Christian Hillhouse from Flock Safety, Steven Macera,
- 2 Lieutenant at Collier County Sheriff's Office Real-Time Operations Center, and Billy
- 3 Gestner, Technical Manager of the Real-Time Operations Center were present at the
- 4 meeting. The equipment from Flock Safety captures evidence that is highly actionable
- 5 for law enforcement, and currently, over 5,000 communities use their solutions.
- 6 Mr. Hillhouse shared that Flock Safety identified two main systems for the Lely
- 7 Community Development District: Sparrow and Candor. Sparrow provides license plate
- 8 recognition at access points, of which there are six identified for the District. Candor
- 9 consists of PTZ (Pan-Tilt-Zoom) cameras that offer continuous live video of areas such
- 10 as lakes and shopping centers. Flock Safety handles everything in-house, including
- 11 sales, onboarding, installation, maintenance, and repairs. Flock can leverage solar
- 12 power and an LTE network so that no hard wiring or Wi-Fi is necessary for installation.
- 13 The cameras were proposed to be specifically focused on ingress traffic to enhance
- 14 alerting capabilities.
- 15 Mr. Fox asked about the capability of these cameras in silver alert situations. Mr.
- 16 Hillhouse said the County has its own cameras that could help in those situations. By
- 17 the end of next month Collier County will have 88 of their own Flock cameras around
- 18 the County along with other LPR systems and County cameras that they have access
- 19 to. The County also has agreements with other communities that allow them access to
- 20 their cameras. Mr. Fox emphasized his desire for cameras to assist with Silver Alerts,
- 21 suggesting that both outbound and inbound traffic should be captured. Mr. Macera
- 22 discussed the process of tracking Silver Alerts using the LPR system, sharing that they
- 23 have many success stories with Flock in tracking ongoing incidents such as robberies
- and burglaries. Mr. Gestner pointed out that not every intersection in Collier County is
- covered by LPRs, which means a Silver Alert could potentially leave Lely and not be
- 26 detected by an LPR. He stressed the importance of establishing public-private
- partnerships to integrate LPRs, PTZ (pan-tilt-zoom) cameras, and video management
- 28 systems to enhance coverage and effectiveness.
- 29 The pricing for the license plate reader system includes \$2,500 annually per camera
- with a one-time installation fee of \$650, though this can be reduced to \$150 if existing
- 31 structures like light poles are utilized. The total annual cost to cover all entrance points
- would be \$15,000, with an additional \$3,000 annually for PTZ cameras at four identified
- 33 locations. Mr. Bowers expressed support for the PTZ system. While signage is not
- required, it might serve as a deterrent. The District's current camera system does not
- offer the same capabilities as Flock Safety's system, which provides one month of cloud

- 1 storage with strong encryption for secure footage. The one-month storage is on a rolling
- 2 basis, so it does not just clear all footage out at the start of the month. Mr. Pires noted
- 3 that there is an exemption of public records for security systems so Mr. Dorrill will not
- 4 have to retain any footage separately. Mr. Hillhouse said that technical support would
- 5 likely be provided from Flock's Miami or Hillsborough hubs.
